Effective May 1, 2021 all Active members enrolled in our Excellus Health Plan are now eligible for Cash Benefit payments. They are as follows:

- Hospital Indemnity Insurance pays cash benefits in the event of hospitalization
- Accident Insurance pays cash benefits in the event of an accident
- Critical Illness Insurance pays cash benefits in the event of certain serious diagnoses

ANNUITY FUND

As of November 5, 2021, all Prudential Annuity distributions and loans have an 8-day waiting period from the date of the request before they can be processed/paid out. This is a rule that is imposed by the IRS. If you call in or go online to make the request, Prudential representatives will explain the wait period.

Please be advised that the Prudential Guaranteed Fund interest rate for the period July 1, 2021 through December 31, 2021 will be set at 1.65%.
